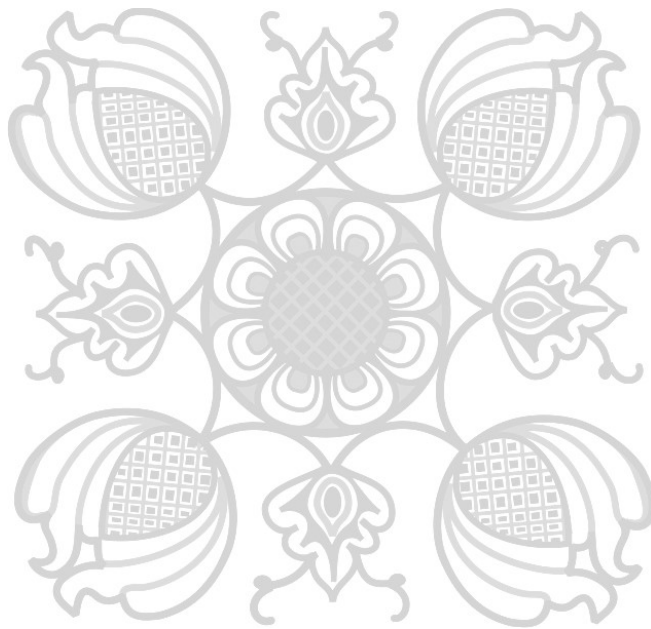

SECRETARY GENERAL’S REPORT FOR THE YEAR 2016

Mr. President,
Trustees,
Members of the Sri Lanka National Trust
Ladies and Gentlemen.

Please permit me to present the Annual Report of the National Trust for the year 2016. At the outset, I am pleased to announce that we have completed another successful year of operations with activities of national and heritage importance as was done during the past. This year also we witnessed a steady growth with regard to its general membership and the heritage activities and projects launched by the main body and its various sub-committees. At present we have a strong body with **388 members*** including **190 Life Members**, majority of whom are senior academics and professionals. Please see the lists of the members attached to the report already circulated, for your information. (*Note: this doesn’t include the members who have not yet subscribed their membership fee for 2016/17.)

The year 2016 also saw the successful implementation of a variety of heritage based activities which benefited its members in particular and the public in general. Conducting of a series of special lectures monthly by selected scholars and specialists, arranging opportunities for the membership and their invitees to join Quarterly Heritage Tours, conducting regular monthly progress review meetings by the Trustees, Management Committee and Scientific sub-committees of heritage specialists, publication of books on heritage subjects and assisting writers and authors on natural and cultural heritage subjects, and maintaining a website to share its experience and knowledge with the public here and abroad, were some of the noteworthy activities implemented during the year under review. Through these activities, the National Trust arranged opportunities for its members and well wishers to meet most of their fellow members and colleagues regularly, in order to maintain a good relationship and share their knowledge and experience in the heritage sector of Sri Lanka. This process also helped to disseminate knowledge on Sri Lanka’s heritage among the members of the society at large.

As one of the major activities which brought the membership together and kept the National Trust alive throughout the year, I wish to highlight its special monthly lecture programme. Of the 93 special lectures conducted from the inception to date, 11 lecture presentations were conducted during the year and they were on country’s heritage covering cultural, historical and natural aspects of the subject. Please see **Annexure I** for details of the 11 lecture presentations and the presenters.

The lectures were of high educational and academic value, and as an activity, the lecture programme brought much publicity to the National Trust and became a source of encouragement to both the membership drive and its fund raising efforts. They also attracted a considerable number of members of the younger generation to become more aware of country’s heritage and also to become members of

the National Trust. From the list attached you could notice that these lectures were presented by a group of highly recognized scholars and professionals in the respective fields. All these lecture presentations were well attended. On behalf of the Trustees and the general membership may I extend our gratitude to all intellects who delivered the lectures in an honorary capacity and the members of the audience showed much enthusiasm during all presentations. Today after the AGM we will be listening to our **93rd special lecture** of this series under the title, “ELEPHANT CONSERVATION AMIDST DEVELOPMENT” by one of our members, Mr. Jayantha Jayewardene.

Another popular activity implemented was organizing **Heritage Tours** on a quarterly basis to selected cultural, historical and natural sites. This **gave** the Trustees and the general membership, an opportunity to meet in smaller groups in the field with their family members and friends during this outdoor activity, which was always conducted under the guidance of eminent personalities in the subject of heritage. The venues selected were mainly lesser known sites and they were of great heritage and historical importance. Three Quarterly Heritage Tours were conducted during the year under review, enabling members who participated to gather knowledge about a number of lesser known heritage sites in the country. As a practice, separate **Tour Guide** booklets were published during the tours for the benefit of both the participating and non-participating members. The latest tour conducted covered the major cultural and historical sites in Anuradhapura and Mihintale.

Being the other major activity, the National Trust continued its **publications programme covering the balance volumes of its series of 10 special volumes on Cultural and Natural Heritage** and the **other series of 7 volumes on Outstanding International and National Artists of Sri Lanka** during the year 2016 as well. Up to date a total of 11 major volumes and 8 other smaller books have been published and they are now available for sale. The latest publication scheduled to be released shortly is “**Railway Heritage of Sri Lanka**”

(Please see **Annexure II** for details of the full lists of volumes.) In addition to dissemination of knowledge among the public on Sri Lanka’s heritage, **the publication project supported the National Trust as a mean of raising funds**. On behalf of the Trustees and the general membership I take this opportunity to extend the gratitude of the Trust to **the authors, the designer and the copy editors** for devoting their valuable time in writing, designing and editing these handsome volumes and so making their contribution to the nation. The National Trust also wishes **to thank the sponsors** who contributed funds to meet the cost of printing, thus extending their generosity to promote the cultural traditions of our country and the trustees who took the initiative to find suitable sponsors towards this worthy project.

The National Trust continued its practice and tradition of conducting regular monthly **Progress Review Meetings of the Trustees** and the **Meetings of the Management Committee** throughout the year in 2016/17 without any interruption. The **128th Meeting of the Trustees** was conducted just an hour ago to work out the policies, plans and strategies to be implemented by the TRUT and to review the progress of projected and planned activities. Twelve meetings were held during the year under review.

The Management Committee, one of the main driving forces behind the success of affairs of the Trust conducted 11 meetings during the year by playing a key role in the running of the Trust and by working out every minute detail of the programmes of activities covering all aspects, paying special attention to fundraising, effective management of finances, the membership drive and the policy frame work in relation to day to day operations. On behalf of the general membership, let me take this opportunity to extend our gratitude, to the members of the Management Committee namely, Prof. Nimal de Silva, Dr. Roland Silva, , Mr. U.L.Kadurugamuwa, Mr. K. Kanag-Isvaran, Mr. N.G. Wickremeratne, Mrs. Ayomi Aluvihare Gunawardene and Mr. Nissanka Weerasekera for working with much dedication throughout the year along with the representatives of the **HNB Sustainability Foundation**, Mrs. Virginia Fernando of the National Trust office and Major General (Rtd) Lohan Goonewardena of M/s F. J &.G de Sarams and other volunteers who supported the committee to reach the present level of success.

Scientific Sub-Committees which are comprised of professionals and outstanding persons in the relevant areas of heritage studies conducted their monthly meetings and discussions on a regular basis covering various academic and research aspects of heritage in Sri Lanka. They extended support to the main body to implement activities belonging to the respective specialized areas of heritage. Their professional input has been of much importance to the activities of the Trust. The **8 Scientific Sub-Committees** which assisted the Trust to achieve results in the respective specialized heritage subjects were **Monuments and Sites, Moveable Artefacts, Natural Heritage, Intangible Heritage, Paintings, Sculpture and Visual Arts, Architectural Conservation, Cultural Routes and Industrial Heritage**. The programmes implemented by them were of immense importance to the Trust and to the heritage of the nation at large. During the year, some of the sub-committees helped to supplement the special publication programme of the Trust, while others conducted workshops and seminars of heritage importance. We thank Dr. Roland Silva, the Past President, Prof. Nimal De Silva, the Chairpersons and members for encouraging and assisting the sub-committees and keeping them going. Our special thank should go to Mr. Prasad Fonseka for serving voluntarily as the secretary to the sub-committees and coordinating the meetings in an efficient manner with the Asst. Secretary , Dr. Nilan Cooray .

The National Trust was successful in reaching its fund raising targets in the year 2016. Due to its various fund raising efforts, the Trust was successful in collecting an **Income of Rs 4,609,189.00** by the end of 2016 and provided sufficient funds to run its day to day activities. **Total spending for the year has been Rs. 2,777,471.00**. Please refer to the **Audited Statement of Accounts** already made available to you for other details. However we still need more sponsors and donors for our special publications programme as some of the balance volumes which are already written have to be printed in order to meet our targets. The sources of funding of the NT have been membership fees, sale of publications, interests from fixed and savings deposits, and contributions from local and international donors, sponsors, and well wishers. The Hatton National Bank continued to contribute generously to meet the day to day expenditure of the Trust during 2016 as well and pledged their support for the year 2017. We thank the Directors of Hatton National Bank for this generous grant. We take this opportunity to thank the Trustees who assisted our fund raising efforts and specially Mr. N.G.Wickremeratne, a member of the

Management Committee for the guidance given to the main body in more effective management and control of its income and expenditure. Also our very special thanks to M/s **Ernst and Young** for auditing of accounts in an honorary capacity from the inception.

As a policy, the Trust continued to extend its support and consultancy services to outside organizations free of charge and also continued to assist the other public and private heritage **institutions** and individuals dealing **with the preservation of heritage in Sri Lanka and to promote international cooperation** on heritage activities during the year. As it was practiced in the previous years, the National Trust continued to associate with the extraordinary work collaboration with public and private sector national and international institutions such as The Department of Archaeology, Central Cultural Fund, Department National Museums, Urban Development Authority, Colombo Municipality, ICOMOS – Sri Lanka, the NPPD, SLIA, Sri Lanka Council of Archaeologists etc., on various heritage projects. The international institutions associated with the National Trust were the International National Trust Organization (**INTO**), the Dutch–Sri Lanka Association and the Centre for International Heritage Activities (CIE), IIAS, IHS and RCE in the Netherlands.

Sub - Committees comprising of National Trust experts have been appointed to give advisory support to complement the special heritage projects of the country , such as the Conservation of Heritage buildings in Colombo (Colombo Fort Heritage Project) , the Jaffna Medieval Grid City and development plan etc., The other Projects undertaken during the year were, to continue the development of **the NT WEBSITE, the Promotion of Modern Arts , Assistance to Small Museums , setting up of a Library for collection of “Personal Libraries” donated by eminent persons and to activate a Volunteer Forum.**

I wish to record here further that the achievements of the National Trust as mentioned above have been mainly due to the team spirit and strong commitment and dedication of the Trustees, the members of the Management Committee, the Members of the Scientific and other Sub-Committees, the general membership and the well wishers. The commitment and the enthusiasm exhibited by the team of volunteers who were with us through-out is also to be greatly appreciated. Let us take this opportunity to thank them all.

Hoping to see another successful year of operations, let me conclude my report for the year 2016.

NOTES TO THE FINANCIAL STATEMENT
For the year ended 31 December 2016

1. Information of National Trust – Sri Lanka

1.1 General

The National Trust – Sri Lanka was founded on the 27th of May 2005. Being an Association not for gain, the Minister of Justice, by his Order made under Section 114 of the Trust Ordinance and published in the Government Gazette Extraordinary No. 1575 / 26 dated 14th November 2008, declared the trust, a body corporate with perpetual succession.

1.2 Principle Activities and Nature of operations

The objects of the Trust are protecting and safeguarding the tangible and intangible cultural and natural heritage of Sri Lanka including sites, monuments, sculptures, paintings, artifacts, music, dance, the fauna and flora of Sri Lanka.

2. Summary of Significant Accounting Policies

2.1 General Policies

2.1.1 Basis of Preparation

The Statement of Financial Position and Statement of Financial Activities together with Notes, (“Accounts”) of the Trust as at 31 December 2016 and for the year then ended, comply with the Accounting Policies and Notes of the Trust.

These Accounts presented in Sri Lanka Rupees have been prepared on a historical cost basis.

2.1.2 Comparative Information

The accounting policies have been consistently applied and are consistent with those used in the previous year.

2.1.3 Income Tax

Income tax is provided in accordance with the provisions of the Inland Revenue Act No. 10 of 2006, on the profits earned by the Trust and is based on the elements of income and expenditure reflected in the Statement of Financial Activities.

2.1.4 Inventories

Inventories have been valued at their actual cost.

2.1.5 Trade and Other Receivables

Receivables are stated at the amounts they are estimated to realize.

2.1.6 Cash and Cash Equivalents

Cash and Cash equivalents comprise cash in hand and demand deposits together with short term, highly liquid investments, readily convertible to known amounts of each and are subject to an insignificant risk of changes in value.

2.1.7 Property, Plant and Equipment

a) Cost

Property, Plant and Equipment are recorded at cost less accumulated depreciation.

b) Depreciation

The provision for depreciation is calculated by using a straight line method on the cost or valuation of all Property and Equipment other than Land, in order to write off such amounts over the estimated useful lives by equal installments as follows;

Depreciation is computed on straight line basis.

Expenses in carrying out the activities of the Trust are recognized in the Statement of Financial Activities during the period in which they are incurred. Other expenses incurred in administering and running the Trust are accounted for on an accrual basis and charged to the Statement of Financial Activities.
