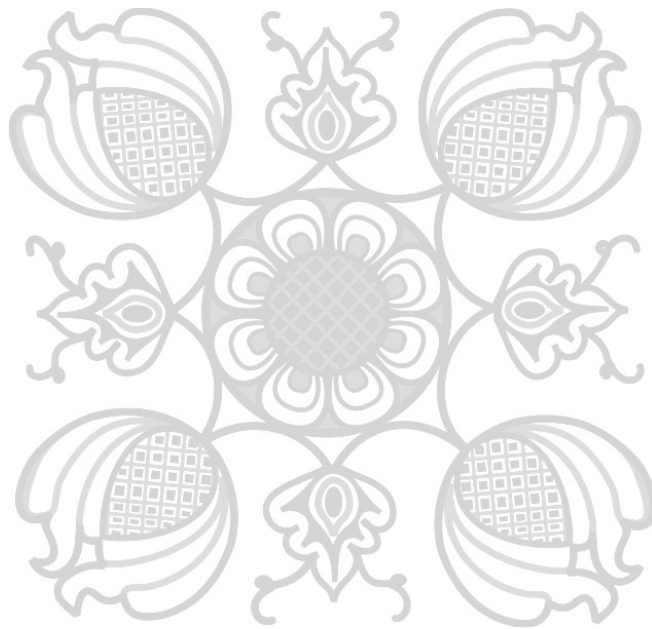

SECRETARY GENERAL'S REPORT FOR THE YEAR 2017

Mr. President,
Trustees,
Members of the Sri Lanka National Trust
Ladies and Gentlemen.

The main purpose of my presentation today is to report briefly to the general membership, on the activities undertaken by the National Trust, its progress during the year under review and also its achievements with regard to its membership drive and finances in 2017. The future and the new projects expected to be undertaken, will be outlined by the President during his presentation.

I am pleased to announce that we have completed another successful year of operations with many activities and projects of national and cultural importance, as has been done before. In 2017 also we witnessed a steady growth in general membership and heritage activities and projects launched by the main body and its various sub-committees. At present we have a strong body of **773 members *** including **219 Life Members** (*figures include members who are yet to renew their subs), the majority of whom are senior academics and professionals. Please see the lists of the members attached to the report already circulated, for your information.

With regard to the activities undertaken, the year 2017 was marked by the continuation of its efforts in order to achieve the objectives of the Trust. This year also we saw the successful implementation of a variety of heritage based activities which benefited its members in particular and the public in general. A series of monthly lectures were conducted by selected scholars and specialists, providing opportunities for members and their invitees to participate in Quarterly Heritage Tours. Regular monthly progress review meetings by the Trustees, meetings of the Management Committee and Scientific sub-committees, publication of books on heritage subjects, assisting writers and authors on natural and cultural heritage subjects, and maintaining a website to share experience and knowledge with the public here and abroad, were some of the noteworthy activities implemented during the period. Through these activities, the National Trust gave opportunities for its members and well-wishers to meet their fellow members and colleagues regularly, in order to maintain a good relationship and share their knowledge and experience in the heritage sector of Sri Lanka. This process also helped to disseminate knowledge on Sri Lanka's heritage among both young and old members of the society.

The special monthly lecture programme implemented by the National Trust could be highlighted as its major activity undertaken during the year 2017. The **monthly lecture presentations** brought the membership together and kept the National Trust alive throughout the year. Of the 104 special lectures conducted from the inception to date, 11 lecture presentations were conducted during the year and the topics of these presentations covered a variety of heritage related subjects such as culture, history and nature, all of them of high educational and academic value. Please see **Annexure I** for details of the 11 lecture presentations and their presenters. As an activity, the lecture programme brought much publicity to the National Trust and became a source of encouragement to both the membership drive and its fund raising efforts. It also attracted a considerable number of members of the younger generation to become more aware of the country's heritage and encouraged the young to become members of the National Trust. From the list of lectures and their presenters one could notice that the lectures were presented by a group of highly recognized scholars and professionals in their respective fields. In 2017 almost all the lecture presentations were well attended. On behalf of the Trustees and the general membership I wish to extend our gratitude to those who delivered the lectures in an honorary capacity. Today after this AGM the 104th special lecture presentation titled, "**Drum's the thing**" (**The Art of Traditional drumming and its new directions in the 20th and 21st centuries**) along with a stage show will be held by the internationally known eminent artist, **Mr. Ravibandu Vidyapathy**.

The other popular activity implemented during the year was the **Heritage Tours** on a Quarterly basis to visit selected cultural, historical and natural sites in the island. This **gave** the Trustees and the general membership, an opportunity to meet in smaller groups in the field with their family members and friends spending long hours to discuss and exchange knowledge among themselves on matters pertaining to cultural and natural heritage. These tours were always conducted under the guidance of knowledgeable personalities. The venues selected were mainly lesser known sites which were of cultural and historical importance. Three Quarterly Heritage Tours were conducted during the year under review, enabling the members who participated to gather knowledge on more than 25 known and lesser known heritage sites in the country. As usual separate **Tour Guide** booklets were published for the tours to benefit both the participating and non-participating members. The latest tour conducted, covered some important cultural and historical sites such as the **World Heritage Site of Dambulla** including the painted caves, Ibbankatuwa Megalithic cemetery and the Painting Museum, under the guidance of Prof. Nimal de Silva.

Implementing of the **Publications programme of the National Trust** covering the balance volumes of its **10 Special Volume series on Cultural and Natural Heritage** and the **7 Volume Series on Outstanding International and National Artists of Sri Lanka** and other **publications** also continued during the year 2017. Up to date a total of **13 major volumes** and **8 other smaller books** have been published and they are now available for sale. Due to the high demand by the public the Trust had to go in for **second editions** on some of the special volumes. Two publications namely, "**Geoffrey Manning BAWA – Decolonizing Architecture**" written by Archt. Shanthi Jayawardene and "**Mannar of Sri Lanka**" edited by Dr. Sarala Fernando were added to the list of special publications during the period under review. Please see **Annexure II** for details of the full lists of Publications/volumes.)

The **publication project supported the National Trust as one of the main means of raising funds in 2017/18**. On behalf of the Trustees and the general membership I take this opportunity to extend the gratitude of the Trust to **the authors, the designers and the copy editors**. The National Trust also wishes to extend its gratitude **to the sponsors** who contributed funds to meet the cost of printing, thus extending their generosity to promote the cultural traditions of our country and **the trustees** who took the initiative to find suitable authors and sponsors.

The National Trust continued its practice and tradition of conducting regular monthly **Progress Review Meetings of the Trustees** and **the Meetings of the Management Committee throughout** the year in 2017/18 without any interruption. The **140th Meeting of the Trustees** will be held to work out the policies, plans and strategies to be implemented by the TRUST and to review the progress of projected and planned activities. Twelve meetings were held during the year under review.

The Management Committee, one of the main driving forces behind the success of affairs of the Trust conducted 11 meetings during the year by playing a key role in the running of the Trust and by working out every minute detail of the programmes of activities covering all aspects and paying special attention to fundraising, effective management of finances, the membership drive and the policy frame work in relation to day to day operations. On behalf of the general membership, let me take this opportunity to extend our gratitude, to the members of the Management Committee namely, Prof. Nimal de Silva, Dr. Roland Silva, , Mr. U.L.Kadurugamuwa, Mr. K. Kanag-Isvaran, Mr. N.G. Wickremeratne, Mrs. Ayomi Aluvihare Gunawardene and Mr. Nissanka Weerasekere for working with much dedication throughout the year along with the representatives of the **HNB Sustainability Foundation**, Mrs. Virginia Fernando of the National Trust office and Major General (Rtd) Lohan Goonewardena of M/s F. J & G de Sarams and other volunteers who supported the committee to reach the present level of success.

Scientific Sub-Committees which are comprised of professionals and outstanding persons in the relevant areas of heritage studies conducted their monthly meetings and discussions on a regular basis covering various academic and research aspects of heritage in Sri Lanka. They extended support to the main body to implement activities belonging to the respective specialized areas of heritage. Their professional input has been of much importance to the activities of the Trust. The **8 Scientific Sub-Committees** which assisted the Trust to achieve results in the respective specialized heritage subjects were **Monuments and Sites, Moveable Artifacts, Natural Heritage, Intangible Heritage, Paintings, Sculpture and Visual Arts, Architectural Conservation, Cultural Routes and Industrial Heritage**. The programmes implemented by them were of immense importance to the Trust and to the heritage of the nation at large. During the year, some of the sub-committees helped to supplement the publication programme of the Trust, while others conducted workshops and seminars of heritage importance. Our special thanks go to Dr. Roland Silva, the Past President, Prof. Nimal De Silva, the Chairpersons and members for encouraging and assisting the sub-committees and keeping them going and Mr. Prasad Fonseka for serving voluntarily as the secretary to the sub-committees and co-ordinating the meetings in an efficient manner jointly with the Asst. Secretary General, Dr. Nilan Cooray .

Financially the National Trust achieved its fund raising targets in the year 2017. Due to its various fund raising efforts, the Trust was successful having a sum **of Rs. 5,795,922.00 as income** by the end of 2017 which provided sufficient funds to run its day to day activities. **Total spending for the year has been Rs. 2,262,282.00** thus leaving a net surplus after Tax of Rs. **3,179,012.00** income over expenditure. Please refer to the **Audited Statement of Accounts** already made available to you for details. The sources of funding of the NT have been membership fees, sale of publications, interest from fixed and savings deposits, and contributions from local and international donors, sponsors, and well-wishers. The Hatton National Bank continued to contribute generously to meet the expenditure of the Trust during 2017 as well and pledged their support for the year 2018. We thank the Directors of Hatton National Bank for their generous grant. We take this opportunity to thank the Trustees who assisted our fund raising efforts and specially Mr. N.G.Wickremeratne, a member of the Management Committee for guiding the main body in more effective management and control of its income and expenditure. Also our very special thanks to **M/s Ernst and Young** for auditing of accounts in an honorary capacity from its inception. However we still need more sponsors and donors for our special publications programme as some of the balance volumes which are already written have to be printed in order to meet our targets.

As was practiced in previous years, the National Trust continued to associate with **other public and private sector national institutions** in 2017 as well in order to achieve it's goals. ICOMOS Sri Lanka, the Department of Archaeology, Central Cultural Fund, Department of National Museums, Urban Development Authority, Colombo Municipality, the NPPD, SLIA, Sri Lanka Council of Archaeologists, Sapumal Foundation are among them. As a policy, the Trust continued to extend its support and consultancy services to outside organizations free of charge and also continued to assist the other public and private **heritage institutions and individuals** dealing with the preservation of heritage in Sri Lanka. **A special committee** appointed to work out a strategy for the preservation of **heritage buildings in Colombo** is now active dealing with the other relevant public organizations such as the CCF, Department of Archaeology and the Urban Development Authority. Efforts to promote **international cooperation** on heritage activities were also initiated during the year. The international institutions associated with the National Trust were the International National Trust Organization (**INTO**), ICOMOS –International, ICCROM, the Dutch–Sri Lanka Association, Prince Claus Foundation, IIAS, IHS and RCE in the Netherlands.

Action was taken to develop further the **WEBSITE of the National Trust** and maintain it effectively with the assistance of the Trustees, Dr. Kavan Ratnatunge and Mr. Nissanka Weerasekera. The other Projects undertaken during the year were, to continue **the Promotion of Modern Arts, and Assistance to Small Museums, setting up of a Library for collection of “Personal Libraries” donated by eminent persons and to activate a Volunteer Forum.**

As was done in the previous years, I wish to record once again that the achievements of the National Trust as stated above have been mainly due to the team spirit and strong commitment and dedication of the Trustees, the members of the Management Committee, the Members of the Scientific and other Sub-Committees, the general membership and the well-wishers. The commitment and the enthusiasm exhibited by the volunteers is also to be greatly appreciated. Let us take this opportunity to thank them all.

Hoping to see another successful year, let me conclude my report for the year 2017.

1. Information of National Trust – Sri Lanka

1.1 General

The National Trust – Sri Lanka was founded on the 27th of May 2005. Being an Association not for gain, the Minister of Justice, by his Order made under Section 114 of the Trust Ordinance and published in the Government Gazette Extraordinary No. 1575 / 26 dated 14th November 2008, declared the trust, a body corporate with perpetual succession.

1.2 Principle Activities and Nature of operations

The objects of the Trust are protecting and safeguarding the tangible and intangible cultural and natural heritage of Sri Lanka including sites, monuments, sculptures, paintings, artifacts, music, dance, the fauna and flora of Sri Lanka.

2. Summary of Significant Accounting Policies

2.1 General Policies

2.1.1 Basis of Preparation

The Statement of Financial Position and Statement of Financial Activities together with Notes, (“Accounts”) of the Trust as at 31 December 2017 and for the year then ended, comply with the Accounting Policies and Notes of the Trust.

These Accounts presented in Sri Lanka Rupees have been prepared on a historical cost basis.

2.1.2 Comparative Information

The accounting policies have been consistently applied and are consistent with those used in the previous year.

2.1.3 Income Tax

Income tax is provided in accordance with the provisions of the Inland Revenue Act No. 10 of 2006, on the profits earned by the Trust and is based on the elements of income and expenditure reflected in the Statement of Financial Activities.

2.1.4 Inventories

Inventories have been valued at their actual cost.

2.1.5 Trade and Other Receivables

Receivables are stated at the amounts they are estimated to realize.

2.1.6 Cash and Cash Equivalents

Cash and Cash equivalents comprise cash in hand and demand deposits together with short term, highly liquid investments, readily convertible to known amounts of each and are subject to an insignificant risk of changes in value.

2.1.7 Property, Plant and Equipment

a) Cost

Property, Plant and Equipment are recorded at cost less accumulated depreciation.

b) Depreciation

The provision for depreciation is calculated by using a straight line method on the cost or valuation of all Property and Equipment other than Land, in order to write off such amounts over the estimated useful lives by equal installments as follows;

Depreciation is computed on straight line basis.

2.1.8 Liabilities

All known liabilities as at the Statement of Financial Position date are included in the Accounts.

2.1.9 Revenue Recognition

Income is recognized on a cash basis.

2.1.10 Expenditure Recognition

Expenses in carrying out the activities of the Trust are recognized in the Statement of Financial Activities during the period in which they are incurred. Other expenses incurred in administering and running the Trust are accounted for on an accrual basis and charged to the Statement of Financial Activities.
