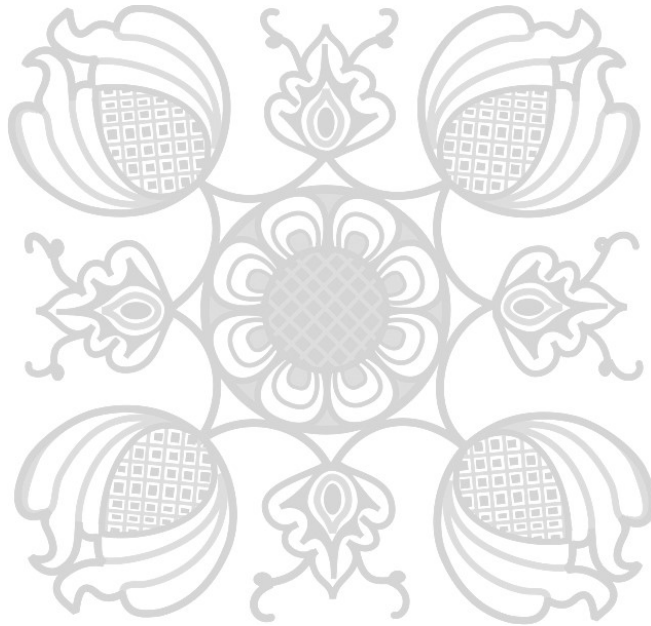

**SECRETARY GENERAL’S REPORT FOR THE YEAR 2018**

Mr. President,  
Trustees,  
Members of the Sri Lanka National Trust.

It is my pleasure to report the achievements and progress on numerous activities and programs of the Sri Lanka National Trust during the year 2018.

I am pleased to record that we have completed yet another successful year of operations with many programs and activities of national importance in the fields of natural and cultural heritage. In 2018 also we witnessed a steady growth in general membership and heritage programs and activities launched by the main body and by its various committees and sub-committees. At present we have a strong body of **Annual Members of 558\*** and **237 Life Members** (\*figures include 438 members who are yet to renew their subscriptions), the majority of whom are senior academics and professionals in the fields of natural and cultural heritage. Please see the lists of the members attached to the report already circulated, for your information.

With regard to the programs and activities undertaken, the year 2018 was marked by the continuation of its efforts in order to achieve the objectives of the Trust. This year too, we saw the successful implementation of a variety of heritage based programs and activities which benefited its members and the general public. The monthly lecture series and the Quarterly Heritage Tours were the most popular programs, providing the membership and the general public to involve in the academic and professional discourses related to a wide range of topics related to natural and cultural heritage, to interact with eminent professionals and academics who made presentations during the monthly lectures, as well as to interact with fellow members, and to visit some of the lesser known, yet important heritage sites and get firsthand experience on the heritage values as well as the challenges for their sustainable existence in the context of threats presented by the nature and by the humans.

Regular monthly progress review meetings by the Trustees, meetings of the Management Committee and Scientific Committees, publication of books on heritage related subjects, assisting writers and authors on natural and cultural heritage subjects, and maintaining a website to share experience and knowledge with the public in Sri Lanka and abroad, were some of the noteworthy programs and

activities continued during the period under review. Through such programs and activities, the National Trust gave opportunities for its members and well-wishers to meet their fellow members and colleagues regularly, in order to maintain a good relationship and share and enrich their knowledge and experience in the field of heritage. In the process, we believe that we have collectively raised awareness of the younger generation, the future custodians of heritage to take meaningful steps for the protection of heritage while allowing benefits of heritage to percolate down to the community at large.

**The special monthly lecture program** implemented by the National Trust could be highlighted as its major activity undertaken during the year 2018. The monthly lecture program brought the membership together and kept the National Trust alive throughout the year. Of the 115 special lectures conducted from the inception to date, 11 lecture presentations were conducted during the year under review and the topics of these presentations covered a variety of heritage related subjects, all of them of high educational and academic value. Please see **Annexure I** for details of the 11 lecture presentations and their presenters. As an activity, the lecture program brought much publicity to the National Trust and became a source of encouragement to both for the membership drive and its fund raising efforts. It also attracted a considerable number of members of the younger generation to become aware of the country's heritage and encouraged the young to become members of the National Trust. From the list of lectures and their presenters one could notice that the lectures were presented by a group of highly recognized scholars and professionals in their respective fields. In 2018 almost all the lecture presentations were well attended. On behalf of the Trustees and the general membership I wish to extend our gratitude to the presenters and the speakers for their input in an honorary capacity. Today after this AGM the 115<sup>th</sup> public lecture will be titled, "**Sufism: A Brief Introduction (Cultural Moors or Mysticism?)**".

The other popular program implemented during the year under review was the **Heritage Tours** on a Quarterly basis to visit selected cultural and or natural sites in the island. This gave the Trustees and the general membership, an opportunity to meet in smaller groups in the field with their family members and friends spending long hours to discuss and exchange knowledge among themselves on matters pertaining to the sites of cultural and natural heritage. Each of these tours was always conducted under the guidance of a knowledgeable personality. The sites selected for quarterly tours were mainly lesser known or least visited sites, but undoubtedly carrying heritage values at national and or local levels. As usual separate **Tour Guide booklets** are prepared for each quarterly tour to be distributed among the participants so that they could read and get some heritage information of the sites in advance while traveling in the bus. The latest tour conducted on 15<sup>th</sup>, 16<sup>th</sup>& 17<sup>th</sup> March 2019 covered important cultural and natural sites in the Jaffna Peninsula as a three day trip, under the guidance of Archt. Ashley de Vos. Special thanks goes to Archt. Jayatissa Herath, a Trustee of the National Trust for compiling the Tour Guide Booklets for each of the Quarterly Tours.

The program to publish the balance volumes of its **10 Special Volumes on Cultural and Natural Heritage**, the **7 Volumes on Outstanding National Artists of Sri Lanka** and other **publications** covering a wide range of subjects related to heritage were also continued during the year under review. Up to date a total of **14 major volumes** and **5 other books** have been published and they are now available for sale. Due to the high demand by the public, the Trust had to go for the **second editions** of some of the special volumes. A new publication namely, “**Yantra – Drawing in Palm Leaf of Sri Lanka by L.S.D. Pieris**” were added to the list of publications during the period under review. Please see **Annexure II** for details of the full lists of publications/volumes). We are also pleased to announce the publication of the book ‘**Collection of Drawings and Paintings by L. K. Karunaratne**’ by Prof. Nimal de Silva which features **The paintings of Mr. Karunaratne**, one of the great servants in the Department of Archaeology, a true link between the earlier generation of archaeologists including Prof. Senarath Paranavitana and the current generation of heritage professionals.

The publication program of the National Trust has continued to be the principle means of fund raising during the year under review as well. On behalf of the Trustees and the general membership, I take this opportunity to extend the gratitude to the respective authors, copy editors and the layout artists for producing these publications to international standard. The National Trust also wishes to extend its gratitude to the sponsors who contributed funds to meet the cost of printing, thus extending their generosity to promote Sri Lanka’s heritage nationally and globally. A special word of appreciation is due to some of the Trustees who took the initiative to find sponsors to make this publication program a reality.

The National Trust continued its practice and the tradition of conducting regular monthly **Meetings of the Trustees** to work out the policies, plans and strategies for implementation of its various programs and activities and to review their progress. Twelve meetings were held during the year under review. The 152<sup>nd</sup> Meeting of the Trustees was just concluded before the commencement of the AGM.

**The Management Committee**, one of the main driving forces behind the success of affairs of the Trust, conducted meetings during the year under review by playing a key role in the running of the affairs of the Trust and by working out every minute detail of the programs and activities covering all aspects with particular emphasis on fundraising, effective management of finances, the membership drive and the policy frame work in relation to day to day operations. On behalf of the Trustees, let me take this opportunity to extend our gratitude, to the members of the Management Committee for working with much dedication throughout the year along with the representatives of the HNB **Sustainability Foundation**, Mrs. Virginia Fernando of the National Trust office and Major General (Rtd) Lohan Goonewardena of M/s F. J &.G de Sarams and other volunteers who supported the committee to reach the present level of success.

**Scientific Committees** which are comprised of professionals and outstanding persons in the relevant areas of heritage studies conducted their meetings and discussions on a monthly basis covering various academic and research aspects of Sri Lanka's heritage. They extended support to the main body to implement activities belonging to the respective specialized areas of heritage. Their professional input has been of much importance to the activities of the Trust. The **8 Scientific Sub-Committees** which assisted the Trust to achieve results in the respective specialized heritage subjects were **Monuments and Sites, Moveable Artifacts, Natural Heritage, Intangible Heritage, Paintings, Sculpture and Visual Arts, Architectural Conservation, Cultural Routes and Industrial Heritage**. The programs implemented by them were of immense importance to the Trust and relevance to the Sri Lanka's heritage sector at large. During the year, some of the sub-committees helped to supplement the publication program of the Trust, while others conducted workshops and seminars of heritage importance. Our special thanks go to Dr. Roland Silva, the Past President, Prof. Nimal De Silva, the Chairpersons and members for encouraging and assisting the sub-committees and keeping them going and Mr. Prasad Fonseka for his voluntary service as the secretary to the Scientific Committees in coordinating the meetings in an efficient manner.

Financially the National Trust achieved its fund raising targets during the year 2018. Due to its various fund raising efforts, the Trust was successful in generating a sum of **Rs. 7,528,879/=** as income by the end of 2018 which provided sufficient funds to implement its activities and programs. Total expenditure for the year under review has been **Rs. 2,988,359/=** thus leaving a net surplus after Tax of **Rs.3,448,907/=** income over expenditure. Please refer to the **Audited Statement of Accounts** already made available to you for details. The sources of funding of the National Trust have been membership fees, sale of publications, interest from fixed and savings deposits, and contributions from local and international donors, sponsors, and well-wishers. The Hatton National Bank continued to contribute generously to meet the expenditure of the Trust during 2018 as well, and pledged their support for the year 2019. We thank the **Directorate of Hatton National Bank** for their generous grant. I take this opportunity to thank the Trustees who assisted our fund raising efforts, particularly Mr. N.G.Wickremeratne, who is also a member of the Management Committee for guiding the main body in more effective management and control of its income and expenditure. Also very special thanks to **M/s Ernst and Young** for auditing of accounts in an honorary capacity from its inception. However, the heavy work program and the activities, particularly the publication of books that are planned in 2019 and beyond, the National Trust still need more sponsors and donors in order to meet our targets.

As was practiced in previous years, the National Trust continued to **associate with other public and private sector stakeholders** in 2018 as well, in order to achieve its goals. ICOMOS Sri Lanka, the Department of Archaeology, Central Cultural Fund, Department of National Museums, Urban Development Authority, Colombo Municipality, the NPPD, SLIA, Sri Lanka Council of Archaeologists, Sapumal Foundation are such institutions among them. As a policy, the Trust continued to extend its support and consultancy services to outside organizations free of charge and also continued to assist other public and private **heritage institutions and individuals** dealing with the preservation of heritage

in Sri Lanka. **A special committee** appointed to work out a strategy for the preservation of **heritage buildings in Colombo** is now active dealing with the other relevant public organizations such as the CCF, Department of Archaeology and the Urban Development Authority. Headed by Archt. Pali Wijeratne, a Trustee, the committee has prepared a report with measured drawings of the buildings in Colombo Fort with funding assistance from the Central Cultural Fund. Efforts to promote **international cooperation** on heritage activities were also initiated during the year. The international institutions associated with the National Trust were the International National Trust Organization (**INTO**), ICOMOS –International, ICCROM, the Dutch–Sri Lanka Association, Prince Claus Foundation in the Netherlands.

Action was taken to develop further the **WEBSITE of the National Trust** and maintain it effectively with the assistance of the Trustees, Dr. Kavan Ratnatunge and Mr. Nissanka Weerasekera. The other Projects undertaken during the year were, to continue **the Promotion of Modern Arts, and Assistance to Small Museums, setting up of a Library for collection of “Personal Libraries” donated by eminent persons and to activate a Volunteer Forum.**

As was done in the previous years, I wish to record once again that the achievements of the National Trust as stated above have been mainly due to the team spirit and strong commitment and dedication of the Trustees, the members of the Management Committee, the Members of the Scientific and other Committees, the general membership and the well-wishers and the sponsors. The commitment and the enthusiasm exhibited by the volunteers is also to be greatly appreciated. Let us take this opportunity to thank them all.

With the hope of recording another successful year, let me conclude my report for the year 2018.

**1. INFORMATION OF NATIONAL TRUST – SRI LANKA**

**1.1 General**

The National Trust – Sri Lanka was founded on the 27<sup>th</sup> of May 2005. Being an Association not for gain, the Minister of Justice, by his Order made under Section 114 of the Trust Ordinance and published in the Government Gazette Extraordinary No. 1575 / 26 dated 14<sup>th</sup> November 2008, declared the trust, a body corporate with perpetual succession.

**1.2 Principle Activities and Nature of operations**

The objects of the Trust are protecting and safeguarding the tangible and intangible cultural and natural heritage of Sri Lanka including sites, monuments, sculptures, paintings, artifacts, music, dance, the fauna and flora of Sri Lanka.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**2.1 General Policies**

**2.1.1 Basis of Preparation**

The Statement of Financial Position and Statement of Financial Activities together with Notes, ("Accounts") of the Trust as at 31 December 2018 and for the year then ended, comply with the Accounting Policies and Notes of the Trust.

These Accounts presented in Sri Lanka Rupees have been prepared on a historical cost basis.

**2.1.2 Comparative Information**

The accounting policies have been consistently applied and are consistent with those used in the previous year.

**2.1.3 Income Tax**

Income tax is provided in accordance with the provisions of the Inland Revenue Act No. 24 of 2017, on the profits earned by the Trust and is based on the elements of income and expenditure reflected in the Statement of Financial Activities.

**2.1.4 Inventories**

Inventories have been valued at their actual cost.

**2.1.5 Trade and Other Receivables**

Receivables are stated at the amounts they are estimated to realize.

**2.1.6 Cash and Cash Equivalents**

Cash and Cash equivalents comprise cash in hand and demand deposits together with short term, highly liquid investments, readily convertible to known amounts of each and are subject to an insignificant risk of changes in value.

**2.1.7 Property, Plant and Equipment**

**a) Cost**

Property, Plant and Equipment are recorded at cost less accumulated depreciation.

**b) Depreciation**

The provision for depreciation is calculated by using a straight line method on the cost or valuation of all Property and Equipment other than Land, in order to write off such amounts over the estimated useful lives by equal installments as follows;

**2.1.9 Revenue Recognition**

Income is recognized on a cash basis.

**2.1.10 Expenditure Recognition**

Expenses in carrying out the activities of the Trust are recognized in the Statement of Financial Activities during the period in which they are incurred. Other expenses incurred in administering and running the Trust are accounted for on an accrual basis and charged to the Statement of Financial Activities.

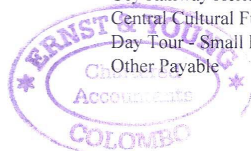

I also wish to place on record the appreciation of the entire membership of the Trust and indeed of all the Trustees of the time devoted to the affairs of the Trust by them, especially of the inaugural President of the Trust, Dr. Roland Silva, who continues as an Honourary President to give strength, support, initiative and encouragement to the Trust in his inimitable style and aplomb.

### **Historic Tours to Heritage Sites**

The Quarterly tours organized to visit places of Historical, Cultural or Natural interest evinced great interest and attendance. Ordinarily, the Quarterly Day Tours were undertaken on the last Saturday of the middle month of each quarter. There were about forty participants on every tour which commenced from the PGIAR premises at Baudhaloka Mawatha at 6.30 in the morning. An academic booklet of about 20 pages is usually prepared for the benefit of the participants for each tour after an informal reconnaissance prior to the tour by a Trustee. The last trip for the year under review was a three day visit to Jaffna, led by Vice-President Archt. Ashley de Vos.

## **Future Plans**

Due to frequent requests for copies of Lectures, the Trust plans to put out selected Lectures in a printed form in a booklet series. A plan to diversify the activities of the National Trust with the assistance of volunteers is also being considered. It is also proposed to conduct a lecture series in outstations as well, such as Kandy and Galle. The Trust also plans to support the establishment of the PGIAR Library. The establishment of branches of the National Trust in the Provinces is another aspect of expansion that will be considered by the Trustees in the coming year.
